## Moab BLM to Host Workshop March 12-13

The Canyonlands country surrounding Moab has intriguing rock art sites within its landscape. In the last two decades visitation to Moab area has increased to over 2 million visitors per year. This increased visitation has brought with it more incidents of graffiti placed over irreplaceable pictographs and petroglyphs. The Bureau of Land Management, Moab Field Office has teamed up with the Utah Rock Art Research Association (URARA), to offer a Site Stewardship and Rock Art Documentation Workshop on Thursday and Friday, March 12-13, 2015 at the Moab BLM office.

The workshop will consist of two days of instruction both in the classroom and in the field. Participants will learn how to properly record and photograph rock art sites, and become site stewards for the Moab area rock art sites. Becoming a rock art site steward means that you agree to document and/or monitor rock art sites in the Moab vicinity. Site stewards are encouraged to visit assigned archaeological sites twice a year to monitor and report changes.

# Preservation Report

On February 11<sup>th</sup>, BLM announced its decision to defer leases on 36 of 53 parcels nominated for oil and gas sales in Canyon Country. URARA had joined Friends of Cedar Mesa, National Parks Conservation Association, SUWA, the National Trust for Historic Preservation and the National Park Service in protesting the leases. We submitted comments on the EA and follow-up comments during the Protest period. We focused on the parcels near Alkali Ridge and Montezuma Canyon. Nine of the eleven parcels we requested were deferred. Thanks to everyone who helped. If you have not emailed Diana Acerson with information about the regional areas where you have experience and knowledge of the rock art, please do. We need everyone.

We did not comment or protest the Color Country EA. Nina Bowen, our regional advisor, reviewed the parcels for lease and determined that BLM archeologist Jared Lundell had done a fine job reviewing leases before the EA. Jared transferred to Moab, so we look forward to working with him there.

Steve Manning and I met with Jenna Whitlock, the temporary state BLM director, and members of her staff. Steve discussed the continuing problems at Utah Lake and recent new rock art damage. Then, we reviewed our latest site map and photographs of rock art in the Reef. Ahmed Mohsen, Director of the Price Field Office, participated in the discussion. We have greatly appreciated Director Mohsen's and Archeologist Amber Koski's encouragement and guidance supporting our efforts to document Molen Reef area rock art. We have made real progress and owe a big thanks to Jon Bailey for his dedication and hard work. The Price Office has modified the forms necessary to provide the information they need to make land use decisions. This allows us to document quickly and focuses our energy on exploration.
