President's Letter

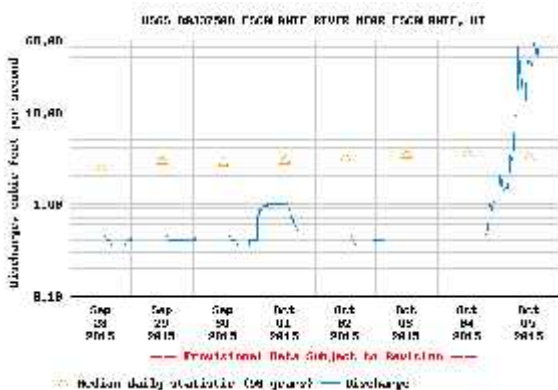

October 3 Membership Meeting Notes

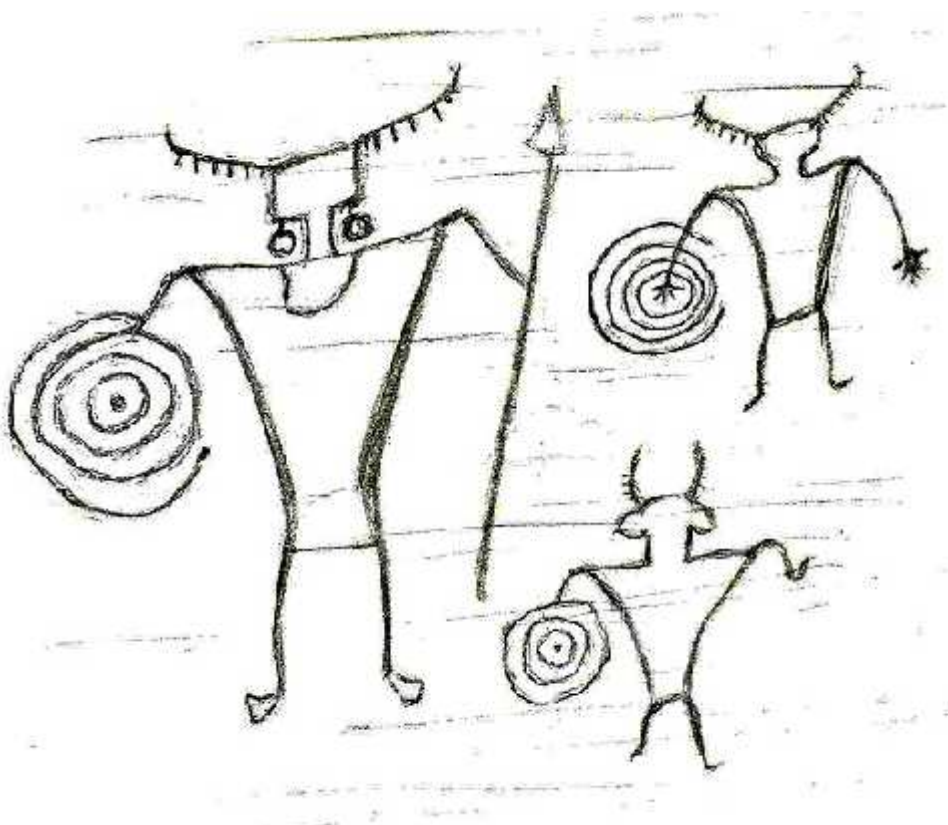

I live in Grand Junction, Colorado with my wife Judi. I am retired from the Colorado Department of Transportation (CDOT) where I was the regional manager of the right-of-way section. Basically I was a real estate appraiser for most of my career, which allowed me to travel all over the state. I first came to rock art in 1982 while visiting a friend in Craig, Colorado. He asked if I wanted to go see some petroglyphs, and we spent the day doing just that. Up to Irish Canyon and Browns Park, to see the Fremont style petros of northwestern Colorado. If you know that area, the rock art is exceptional (like Vernal), and from then on I was hooked.

Judi and I moved to Grand Junction in 2000 (from Greeley, which is 50 miles north of Denver), and that's when things really changed for me. It was now only 90 minutes to Moab. Red canyons and rock art were all around, and it got better if I drove west.

I turned 67 this fall, and my long-range plan is to hike until I am 97, then look at my pictures from then on. So there is plenty of time. And the good news, no matter what, I know there will always be another unexplored canyon.

I grew up in mining towns scattered across the mountains of Colorado and the Uintah Basin. Growing up surrounded by the beauty of the West I became fascinated by rock art and the history of the Western United States. I am now a member of several groups involved in researching, investigating, discussing, and publishing facts and stories about the history including social, political, economic, and religious background of the Western United States.

To these and other groups I have given talks, and had articles published, on many topics including, "The Evolution of the Danites & the Mormon War of 1838", "The History of the Gilsonite Industry of the Uintah Basin", "The National Western Stock Show", "Colorado First Tourist Railroads", "The Last Killing in a Sheep and Cattle War in Colorado", and "When Two Became One - The Story of Two East Denver Parishes and a Monsieur or Two".

Active Preservation Projects 2015

At the 2015 Symposium in Escalante, we announced the current BLM projects that many URARA members are involved with. The three projects listed here need your support and input:

1. Lake Mountain Target Shooting Closure- Pony Express Resource Management Plan Amendment. The proposed amendment is to extend the no target shooting area on Lake Mountain, west of Utah Lake. The proposed comment period on this amendment to the Resource Management Plan will be announced soon. Please help us protect the unique 10-13,000 year old petroglyphs at Lake Mountain.

Anticipated Timeline:

- Draft Plan Amendment and Environmental Assessment preparation Fall/Winter 2015
- 30-day comment period on Draft Plan Amendment and EA Winter 2015
- Prepare Plan Amendment and EA Winter 2015/Spring 2016
- Protest Period on Proposed Plan and EA Spring/Summer 2016
- 60 day Governor's Consistency Review Summer 2016
- Issue Decision Record/RMP Amendment Winter 2016 Moab Master Leasing Plan and Draft Resource Management Plan Amendments/Draft Environmental Impact Statement

2. The Moab Master Leasing Plan and Draft Resource Management Plan. Environmental Impact Statement is available for public review. *The official public comment period began August 21, 2015, and ends on November 19, 2015. This document includes four alternative proposals for managing mineral leasing and development pertaining to oil, gas, and potash on public lands managed by the Bureau of Land Management (BLM). The BLM formulated a reasonable range of alternatives based on issues raised during scoping, planning criteria, public comments received on the preliminary alternatives, guidance applicable to specific resources, and the use of an interdisciplinary team of BLM resource specialists and cooperating agencies.

Paper copies of the Moab MLP and Draft EIS are available for public inspection at the Grand County (257 East Center Street, Moab, Utah 84532), Monticello (80 North Main Street, Monticello, Utah 84535) and Salt Lake City (Reading Room, 210 East 400 South, Salt Lake City, Utah 84111) public libraries. 3. February 2016 Oil & Gas Lease Sale. The Bureau of Land Management (BLM) Utah Canyon Country District just completed the public comment period on an environmental assessment (EA) analyzing the BLM’s proposal to offer seven parcels covering 8,121 acres in the Moab Field Office at the February 2016 oil and gas lease sale. Additional information about the proposed parcels is included in the EA, which is available for public review. An electronic copy of the EA can be found online at: http://www.blm.gov/ut/st/en/prog/energy/oil_and_gas/oil_and_gas_lease.html Hard copies of the EA can be obtained in person at the Moab Field Office, 82 East Dogwood, Moab, Utah, 84532. The public review and comment period closed at 4:30 p.m. on Oct. 19, 2015.

*The protest period will begin November 13th and ends December 14th.

*PLEASE NOTE: When commenting on any project during its comment/protest periods, and before including an address, phone number, email address, or other personal identifying information in any comments to the BLM, be aware that the entire comment – including personal identifying information – may be made publicly available at any time. Requests to withhold personal identifying information from public review can be submitted, but the BLM cannot guarantee that it will be able to do so.

I/ we _____ am/are writing regarding an amendment to the Pony Express Resource Management Plan (RMP) and associated environmental assessment (EA) for the Eastern Lake Mountains area west of Utah Lake, to determine the suitability of and potential for target shooting restrictions on public lands in this area.

We are strongly opposed to target shooting in the area due to the impacts and threats to cultural resources, public safety, and due to the threat of wildfires triggered by shooting. To fully protect the unique prehistoric petroglyphs and recreational users we recommend and support closure of all

of the BLM’s public lands in Township 7 South - Range 1 West in sections 13, 24, 26, 27 and 28 to the discharge of all firearms.

Since 2010, BLM law enforcement has documented 18 incidents of theft, vandalism, and other crimes involving the cultural sites in this area. Motorized access needs to be restricted and shooting needs to be stopped permanently.

We recommend the following:

1. Close these public lands to recreational target shooting
2. No Motorized Vehicle traffic except on permitted and/or designated access roads ONLY to be implemented immediately
3. Prohibit overnight camping and other associated activities for prevention of wild fires
4. Provide enforcement of closure to insure public safety and protection of cultural resources and the surrounding environment

Protection of the cultural resources of the Lake Mountain area will help preserve Utah’s heritage. Once again, we strongly encourages the permanent closure of the Lake Mountain Area to recreational shooting, motor vehicle access, fires and overnight camping.

Volunteer Needed – Preservation Coordinator

The URARA Preservation Committee is looking for one of our members to be the "Coordinator" of contact information for URARA's preservation efforts within the Vernal, Utah, BLM field office jurisdiction.

URARA's Preservation Committee is in the process of setting up this program to gather information through 10 coordinating members who may or may not know of rock art locations within BLM field office jurisdictions around the state. Initially these key members will be responsible for the collection of contact information from URARA members, or other persons, who may know of rock art sites that could be affected by land use activities in any given BLM field office area. Specifically, when oil and gas leases are up for sale, or some activity that we know will definitely impact known rock art locations.

At the present time we have a Coordinator for 9 of the 10 BLM field offices around the state. We need someone for the Vernal field office. That member does not need to live in the area of the field office, although that would help. Knowing sites in the area would be beneficial, but not a prerequisite. Being able to collect contact information from persons who do know of sites is the focus.

The Vernal field office now has 3 archeologists, hired within the past 3 months. They are enthusiastic about working with URARA in preservation of rock art sites. This will be a great opportunity to meet and get to know them.
